\*The KSV1870 SmartBonus is for corporate insolvencies in Austria and applies only to claims from deliveries and services, but not to loans of any kind (bonds, crowdfunding, etc.) It can be used only once per case. The amount of the claim is calculated by adding up all individual accounts that are outstanding against a debtor. Court fees will be charged. When it comes to personal bankruptcies, our member vouchers continue to be available to members as usual.

I will use my member voucher to file a claim (giving me a 50% discount on costs of representation or, in the event of personal insolvency, covering up to EUR 5,000 in representation and court fees.)
